## 1. Meeting Opening:

### 2. Notice of Intent – 2 Powder Mill Rd

- a. Due to the lack of new information, Agent requested the hearing be continued to June 8, 2023 and therefore the hearing was continued without discussion.
- b. John Dwyer made a motion to approve continuing the hearing to June 8, 2023. Sarah Measures seconded the motion and it passed unanimously.
- 2. 3 Wood Lane Request for determination of Applicability
  - a. The Commission heard a Request for Determination of Applicability under the Massachusetts Wetlands Protection Act and the Maynard Wetlands Administration Bylaw filed by Keith Blaszak of 3 Wood Lane Maynard, MA 01754 for the installation of a natural gas pipe in the existing paved roadway and front yard within the 100 foot buffer zone at his residence.

- c. John Dwyer made a motion to close the hearing. Sarah Measures seconded the motion and it passed unanimously.
- d. Conditions Wattles must be installed and area be stabilized with lawn or plantings. All plants installed shall be native
- e. John Dwyer made a motion to make a negative determination with conditions under the Wetlands Protection Act and use of electronic signatures. Steve Smith seconded the motion and it passed unanimously.
