at the current "Green Meadow" water treatment facility.

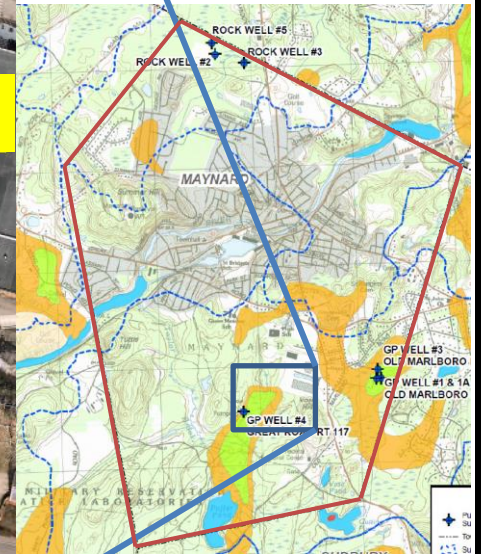
