


Q1 Did you attend the 2023 Special Town Meeting on October 10th?



1	<p>Things went very wrong at voter check in, resulting in the meeting start time being delayed by 50 minutes. I see a number of contributing factors: - Larger than normal attendance - A new electronic registration system - I, at least, did not receive any advance warning to expect different procedures at this meeting. Please educate voters ahead of such changes. - A novice and noisy crowd which contained many voters that do not often attend town meeting and were unfamiliar with the check-in procedures - Registrars that were having a lot of difficulty hearing the names of the voters, resulting in many tries to find a voter's name - The electronic system required the registrar to type parts of the voter's last and first names. This proved much slower than the old paper method where the registrar could just scan down the page to find the voter's info. We must improve the procedures around voter check in. I have attended most Annual and Special Town Meetings in Maynard in the past 10 years. The long delay to check in all of the registered voters was unprecedented in my experience. The last meeting I recall with such a large turnout was the vote to fund the new High School, but there was not such a bottleneck at registration. What to do in response to a large turnout is a choice. Suggestion: If we don't have official policies on how to handle large crowds at Town Meeting, we need to form them. It seemed like we were improvising a policy on the spot. I don't want to see such a large delay to the meeting start time again. Suggestion: The meeting should start as scheduled (or at most 10 minutes later) and latecomers can join when they are able. If they miss part of the meeting, then they will learn to come earlier the next time. If the policy is publicized before the meeting (say, in the warrant), then I feel this would be fair. Town Moderator stated that there were many people who had been in line by 7:00 PM (the scheduled start time) who had not yet been registered even 20 minutes later. Suggestion: We should declare and publicize an earlier cut off. Say, the meeting start will only be delayed until all people in line by 10 minutes before the scheduled start time have had time to register. Before the meeting began, Town Moderator stated that total attendance could be an estimated 1200 people (counting those checked in and those still in line), but the highest number of ballots cast on any one article was 762 (on Article 3). So either the estimate was off by 400 people or 400 people gave up and left. Neither is a good outcome. Suggestion: Reduce verbal communication during check in. Allow voters to use some form of written information. If a voter could display a written name, then the registrar could read it and receive accurate information more quickly. Even better, allow voters to identify themselves directly to the electronic system, say with a barcode or RFID. Suggestion: Allow both electronic and (as a backup) verbal check in. If you can get even some people through the line faster, it will speed the entire process. Yes, voters would have to prepare their document ahead of time, but I'm specifically proposing a system that is opt-in, so documents will not be required. Based on I when I entered the check in line (6:45 PM) and the number of voters in the auditorium ahead of me, I estimate that check in ran from 6:30 PM through 7:50 PM, a duration of 80 minutes. That's far too long. Each voter received a paper receipt after registration which was then surrendered as they entered the auditorium. Those receipts contained personally identifiable information. 56	1. The registration process needs to be refined. The crowd was so loud and the people at the table had trouble understanding what I was saying to spell my name. They refused to let me enter the letters myself (which would have saved a lot of time, rather than me trying to yell over the crowd noise). As a result, what used to take about 1 minute took nearly 5 minutes. The old system (broken down by the first letter of the surname) at least had the people looking for the correct letters in the alphabet rather than guessing at which of the 26 letters I said. 2. Taking the printout slip with my full name and address to pick up the ballot and pencil is an unnecessary step. There were two people at each check-table--one of them could enter the information to verify voter status, and the other should be handing out the ballots as the voters are registered. Instead, I was left wondering if my full name and address information were to be dumped into regular recycling or whether they would be securely destroyed (shredded). When I asked the person at that table whether the slips would be shredded, she didn't seem to know. That's not confidence-inspiring. 3. The meeting time on the warrant stated that the meeting was to start at 7 PM given a sufficient quorum of people. It was clear by 6:45 PM (the time that I finally made it into the auditorium) that there was a quorum. Instead, the meeting was delayed time and again for people who did not allow for sufficient time to get through the registration process by 7 PM. Every other town meeting begins at the start time, regardless of how many people are still in line. Several times, the moderator stated that they had not anticipated the crowd that this meeting attracted, which left me wondering how the moderator and town meeting staff could be so out of touch. The Green Meadow proposal had attracted a lot of attention for several months, and the proposal for the senior center was similarly promulgated on social media outlets. It was clear to me that this would be a big turnout meeting. The crowd that showed up for the vote on funding the new high school was a similar-sized crowd. Back then, people were able to show up with enough time to get through the registration process before the meeting was slated to start. 4. The AV status of this meeting was below par. Several times, the students running the microphones were not attentive enough, which led to time spent waiting for them to turn on microphones for speakers on the stage and at the aisles. 5. The moderator, at times, was unintelligible as he spoke across the microphone and not into it. Many other presenters were similarly unintelligible. Before the next meeting, all presenters should be required to take a course on how to speak into a microphone and an enunciation class so that their words are not run together in such a way that it sounds as if they're speaking with a mouth full of marbles. 6. The moderator should make clear, at the start of the meeting, what the proper etiquette is. At least four times during the meeting, members of the town meeting body erupted in applause and cheers. clear that this is unacceptable behavior at the start, that may have been quelled. Additionally, there were several small children present at the meeting, which would not have been a problem if their parents had taken them out of the room when they started to cry. Instead, the process of understanding the presenters' garbled speech was made even more difficult. At previous town meetings (with a different moderator), the policy was that children could stay so long as they were quiet and did not disrupt the proceedings. Go back to that policy. Also, there needs to be an announcement that if people choose to leave the meeting in progress, they should leave quickly and quietly so as not to disrupt the rest of the meeting. I was unable to either hear or see any of the presentation of the article following the announcement of the school vote as people stood up to leave and stopped to chat along the way. If town meeting is truly a legislative body and if the moderator had any control of the meeting, he would at least suspend the introduction of new items while there's such commotion. Ideally, the moderator would have made so clear that the meeting is serious business so as to state that if people intended to leave at some point before the meeting was over, they should be seated in the overflow room so as not to disrupt the ongoing proceedings. Additionally, at previous town meetings, the expectation was that every voter had to have a seat. At this town meeting, there were many people standing at the back of the room continuously throughout the meeting (not just the usual police officers). Guests used to be segregated into the guest section so that they could not influence town meeting members' votes. Instead, I saw people with Guest tags seated throughout the auditorium. Has that policy also been done away with?






