WASTEWATER FACILITY OPERATION AND MAINTENANCE SERVICES

The Town of Maynard (“the Town”) is seeking proposals from qualified firms capable of operating, managing, and maintaining the Town’s wastewater treatment system in a safe and efficient manner, and in compliance with all applicable laws and regulatory requirements. This contract shall be for a five (5) year term and can be renegotiated at the end of this term for an additional two (2) one-year extensions, at the sole option of the Town.

The proposal advertisement and awarding of the Contract shall be in full compliance with Chapter 30B of the General Laws of the Commonwealth of Massachusetts as last revised. The Town of Maynard reserves the right to reject any or all proposals, to waive any informality in the proposals, to request further information with respect to any proposal received or to accept the proposal deemed to be in the best interests of the Town of Maynard.
