### Project Description

1.Goals:The MHC would like to preserve as many of the early gravestones of residents of Assabet Village and early Maynard as possible.To that end we sponsored a similar CPA application last year and were successful in preserving through cleaning,repair and resetting over 40 gravestones.This is done as part of Maynard's Sesquicentennial in 2021.The stones treated in Part 1 are seen as a huge success by town officials and MHC and we have had several residents comment at what a difference they see in this early part of Glenwood as a result of this first preservation effort.

2.Community Need:Many of these early stones are broken or in need of such rehab that this project is much needed and timely with our sesquicentennial celebration.Many of these stones belong to the early Maynard residents who signed the legislation creating Maynard and were very early town leaders.

3.Community Support: DPW and Mark Currier have especially have been very supportive of Part 1 and now this Part 2.As noted in our answer to #1 above several residents have commented how much improved this section of the cemetery is due to this project.

4.Budget:We are again asking for \$10,000.Funds are spent under the supervision of DPW,cemetery personnel and MHC.

5.Funding:DPW offers assistance to restorer as needed and help to MHC to identify stones,provide water,and other resources as needed during restoration process.

6.Timeline:After Town Meeting approval and completion of Grant agreements company doing the restoration work is scheduled .So anytime from August to end of October of following spring.

7.Implementation:This project is sponsored by MHC working cooperatively with cemetery personnel.

8.Maintenance:Cemetery trust fund

### Additional Information:

We have provided a list of the gravestones to be preserved,a cemetery map showing location of work.The restoration company provides a written report with before and after pictures of each stone and a description of the work done on each stone.This report is then provided to DPW ,MHS and CPC.
