



# TOWN ADMINISTRATOR REPORT

**March 4, 2025**



## ADMINISTRATION

- Town Administrator (TA) Johnson and Assistant Town Administrator (ATA) Stephanie Duggan began regular collective bargaining agreement negotiations with the LIUNA Professionals union and LIUNA Laborers union. TA Johnson expects to begin negotiations with Director of Public Works (DPW) Justin DeMarco.
- TA Johnson offered letters of support for Comcast and Verizon (respectfully) for their application of state endorsement for broadband expansion to help unserved and underserved customers in the community.
- TA Johnson received the Regional Housing Services Office (RHSO) report that shows Maynard enjoys “safe harbor” from imposed Ch 40 housing development until October 1, 2025, and that Maynard has a 9.98% Subsidized Housing Inventory (SHI) and requires 10% for ongoing “safe harbor”. It should be noted that long-time director, Liz Rust, is planning to retire in the upcoming fiscal year.
- TA Johnson and town staff hosted town officials from Concord to review the impacts and lessons-learned in the development of Maynard Crossing, as Concord prepares for the turnover of the vacant MCI Concord property.
- TA Johnson hosted the evaluation team for the Request for Proposals (RFP) seeking space to lease for a new senior center to tour the proposed spaces.
- TA Johnson joined Sally Warner of the Sustainability Committee in a public hearing with the Department of Public Utilities (DPU) in the agency’s consideration of the town’s proposed community electricity aggregation program.
- TA Johnson attended and presented recommendation to the Budget Sub Committee meeting held Wednesday, February 26, 2025.
- TA Johnson coordinated the pre-contract application for the MassWorks awarded grant of \$500,000 for the design of upgrades to the Powder Mill Pump Station.

- TA Johnson expects to join Library Director Jean Maguire and officials of Wayland, Weston, Stow, Acton and Maynard, at the Goodnow Library in Sudbury for the 2025 Library Legislative Breakfast on Friday, March 7<sup>th</sup>, 2025.
- TA Johnson is planning to take vacation on Friday, March 14, 2025.
- ATA Duggan attended a financial forecasting seminar hosted by the state's Division of Local Services in Amesbury, MA.



## **PUBLIC WORKS**

- It's been reported that the traffic lights for Concord/Acton Streets may be arriving in the coming two-four weeks, and may be installed by the end of March.

## **MUNICIPAL SERVICES**

- The Office of Municipal Services (OMS) worked with Maynard Fire Department (MFD) to “dispose” (sell) the town's decommissioned E-One Cyclone fire truck. Using the same auction broker that sold goods in the old firehouse at 1 Summer, the Town received \$5,500 to purchase the used truck from the winning bidder, Cumberland Fire Department of Rhode Island. This sale is in accordance with procurement practices for disposition of goods by municipalities.

- Chief Lawless attended a multi-day professional development session in Worcester hosted by the Fire Chiefs Association of Massachusetts (FCAM).

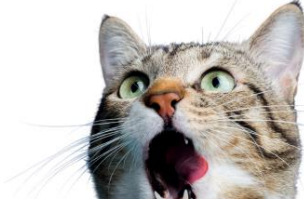

- Pop Up Art School's felted wool squirrel workshop brought out fans in support of National Squirrel Appreciation Day.



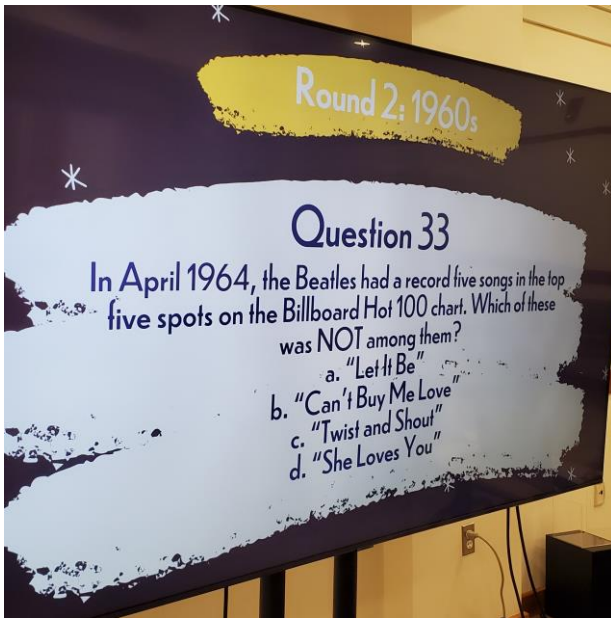
